FACTS: Decedent Candida Rodriguez was diagnosed with signet cell ring stomach cancer in May 2019. After four cycles of chemotherapy, she was referred to defendant Dr. Aziz Ahmad, a City of Hope cancer surgeon, for a gastrectomy with feeding jeujenostomy. This procedure was performed at Emmanate Foothill Presbyterian Hospital in Glendora on Sept. 23, 2019. Post-operatively, the decedent recovered uneventfully for five days. Unfortunately, on September 29th, she started leaking tube feed into her abdominal drain. She also developed septic shock with low blood pressure, fever and a low white blood cell count. Dr. Ahmad decided to attempt to treat the patient non-operatively with IV

fluids and antibiotics. The patient was moved to the ICU. Three days later on October 3rd, her mild clinical improvement stopped and Dr. Ahmad decided to return the decedent to surgery, where he found a perforation in her bowel the size of his hand. He believed the area of necrosis was caused by a chemical reaction to the leaking tube feed. He did a repair of the bowel and had to also re-do the esophagojejeunal anastimosis. Eventually, this connection fell

apart and the decedent, age 51, died of sepsis on October 13, 2019.

PLAINTIFF'S CONTENTIONS: Plaintiff contended that Dr. Ahmad should have immediately returned the decedent to surgery on September 29 or 30 when the leak was appreciated. The sepsis was not going to improve without controlling the source by repairing

the large hole in the bowel.

DEFENDANT'S CONTENTIONS: Dr. Ahmad contended that it was reasonable to try and control the bowel leak and sepsis non-operatively. He didn't know until he reoperated three days later that the bowel defect was as large as it was.

INJURIES: Death of Candida Rodriguez, leaving behind her two adult children and husband.

RESULT: Defense verdict.
